

# **Changes to Certified Practice Competency and Decision Support Tool Documents**

### **Key Messages**

- Since stepping into certified practice DST stewardship in 2020, NNPBC has received significant feedback from certified practice nurses, educators, and provincial leaders regarding the Competencies and Decision Support Tools (DSTs) for certified practice.
- In response to this feedback, Certified Practice DST Working Group members and the NNPBC Professional Practice Team identified that there was significant overlap and duplication across DSTs, as well as a need to update content across every DST.
- The NNPBC Professional Practice team and the Certified Practice Competencies Working Group also identified
  the need to amalgamate the four existing competency documents for certified practice into a single, unified
  competency document.
- Given the significant number of changes required across all documents, a decision was made to approach
  changes to the Competencies and DSTs for certified practice in two phases. Phase 1 is focused on migration of
  existing content to a new framework for DSTs. Phase 2 is focused on content revision and is guided by the
  NNPBC Certified Practice DST Stewardship Plan.

### Phase 1: Migrating Existing Content to New DST Framework and Unifying Competencies

- The Certified Practice DST Steering Committee approved a new framework for certified practice DSTs, which
  clearly articulates the different types of documents that make up the DSTs for Certified Practice and the unique
  purpose of each DST.
- The new framework is designed to eliminate duplicate content and streamline DSTs to increase clinical utility and ease of use. The new framework specifies two types of DST documents: *Assessment and Diagnostic Guidelines* and *Care and Treatment Plans*.
- Table 1 below provides more detail on the new framework and document types. Please note: there are no changes to content in Phase 1.
- Table 2 below provides an overview on how the existing DSTs are changing under the new framework.
- A unified certified practice Competency document has been created to replace the existing four separate
  competency documents for each certified practice area. The new document articulates competencies that are
  beyond entry-level practice and that constitute the expanded scope of all certified practice nurses. The new
  Competency document also identifies competencies that are unique to each area of certified practice.
- The revised Competency and DST documents will be posted on the NNPBC website on December 1, 2023 for 90 days before coming into effect on March 1, 2024.

#### **Phase 2: DST Content Revision**

- Phase 2 is focused on content revisions for all DSTs, including integration of current evidence and updates to practice guidance.
- Phase 2 will commence in January 2024 and will follow the DST revision cycle established in the NNPBC Certified Practice DST Stewardship Plan.
- Content change request received during Phase 1 continue to be tracked and will be used to inform content revisions in Phase 2.
- NNPBC continues to make rapid changes to DSTs as needed to align with and respond to changing regulatory and practice needs.



# **Table 1. Certified Practice DST Framework**

**Clinical Decision Support Tools (DST)** – Refers to the suite of tools developed and maintained by the Association of Nurses and Nurse Practitioners of British Columbia (NNPBC) that guide and articulate the scope of the practice of Certified Practice Registered Nurses. Clinical Decision Support Tools are built on the foundational competencies for Certified Practice Registered Nurse practice and align with the legislative and regulatory framework governing this practice.

Below are the tools that fall under the umbrella of 'DST'.
